Secretary's Report Marie Ferguson:

*Minutes from Reorganization meeting January 3, 2023, Regular Township Meeting January 3, 2023, Special Meetings January 11, 2023 and January 16, 2023. Tim motions to accept minutes as written. RC seconds. Carried.

***Secretary-Treasurer's Report Michele Kriznik:**

Marie motions to pay Green Towing bills. RC seconds. Tim abstains. Motion carried.

Supervisors Report Robert Cassidy:

*Subdivision – Barnhart/Three Brothers, Atlasburg Road. Smith Township Planning Commission Anthony Gianfrancesco motion to accept subdivision with condition that all signatures are on plans. Dave Thomas seconds. Passed unanimously. Tim motions to accept Barnhart/Three Brothers subdivision. Marie seconds. Carried unanimously.

*Ordinance 2023-1, Energy Solar Systems. At January Planning Commission meeting, they recommended to the board to consider the proposed amendment to allow solar facilities as a conditional use in certain zoning districts. We need to hold a hearing to consider amending it. Hearing will be held on March 20, 2023 at 5:30 pm at the Smith Township Municipal Complex. Tim motions to accept hearing date to consider proposal. Marie seconds. Motion carried. Discussed Battery Storage Facilities.

*Add Kyle Golik to the Zoning Hearing board. Mike Oriskovich's term was up on December 31, 2022. Kyle will take Mike's place on board and Mike will drop to alternate.

*Notification – Act 223/13, Yonker, George Well Site (Mt. Pleasant Twp.). 11360 13 H Modification. Notification of gas site.

*Robert Cassidy and wife, Cathy, were taken off Smith Township Health Insurance backdated as of January 1, 2023.

*Resolution 20235R, Alleyways – Morgan Land Co. Township is taking no action to make public certain alleyways in Harmon Plan of lots that was Recorded at Recorder of Deeds Office Plan book 5 – Pages 66-67, where Chris Morgan has Elemental Shelter Solutions. Closing paper alleys. (Not vacating roads that were made public). This resolution confirms there was never action to adopt it. Tim motions to accept Resolution 2023-5R. Marie seconds. Motion carried unanimously.
